2. All sums for goods and services are due and payable within 30 days from Printgraphics invoicing date.
3. Printgraphics reserves the right to hold orders in the event Purchaser's account becomes delinquent.
4. In the event the account becomes delinquent and is turned over to an attorney for collection, the Purchaser shall pay reasonable attorney fees and court costs and disbursements.
5. Goods and services purchased from Printgraphics are not payable in installments, but are payable in full as stated in invoice.
6a. In the event any dispute (involving items invoiced from Vandalia, OH), claim or claims by Printgraphics against Purchaser, or Purchaser against Printgraphics, in any matter or thing having a value of less than \$10,000, Purchaser consents that the Municipal Court situated in Montgomery County, State of Ohio, shall have jurisdiction of the Purchaser for the determination of such claim or claims.
6b. In the event any dispute (involving items invoiced from Nevada, IA), claim or claims by Printgraphics against Purchaser, or Purchaser against Printgraphics, in any matter or thing having a value of less than \$10,000, Purchaser consents that the Municipal Court situated in Story County, State of Iowa, shall have jurisdiction of the Purchaser for the determination of such claim or claims.
7. Printgraphics reserves the right to terminate the extension of any credit at any time.
8. Neither applicant, or any entity in which the applicant has or had an interest, has filed any petition in bankruptcy or made any assignment for the benefit of creditors or has been a party to any insolvency proceedings within five years of the date of this application.
